At the above date and time Lt. Anderson requested for me to take a report from victim/reporting party Sais at the front office.

Contact was made with Sais, who stated that on 2/24/91, at approximately 2015 hours, she was at her residence, 334 Capitol Street, and was also babysitting for her roommate, Scott Loeliger. She stated that she then heard someone knocking on the door and went to answer the door. She stated that when she opened the door, she noticed that it was Sadia Ali-Loeliger. Sais explained that at the present time Scott and Sadia have a civil case pending regarding child visitation and other issues. See the restraining order, report #90-101427.

Sais stated that she told Sadia that she will be bringing the baby to her right away. She stated that Sadia pushed the door open and attempted to enter the residence. Sais told Sadia to please leave the residence. Sais told Sadia at least four times to leave, however, Sadia started following Sais to the bedroom.

Sais stated that upon picking up Scott's baby, Sadia pulled her hair hard enough to force her to take one or two steps backwards. She said she was able to keep balance at that point. Sadia told her to give her the baby. She stated that Sadia started grabbing the baby, at which point she decided to give it to her to avoid injuries. Again Sais told Sadia to leave her residence. She stated that every time Sadia would respond that she did not have to leave the residence.

Sais stated that after she was unable to communicate with Sadia, she decided to walk out of the bedroom, at which point Sadia slapped her

on the right side of the face once. Sadia stated that she was not knocked down, however, that the blow, "Stun." Sais stated that as she was exiting the room, she noticed that Sadia was taking decorations off of the wall. She also noted that Sadia took one of her own blankets, but subsequently gave it back to her.

Sais stated she was trying to reason with Sadia so she could leave the residence when Sadia heard her, Sais, baby crying. Sais stated that Sadia told her let's go see your baby because I heard that Scott is his father. Sais told her that she was willing to show her a picture of her baby's father. Sais stated that Sadia told her that in fact she didn't care if it was a relationship between her and Scott.

Sais stated that Sadia made several threats against her and wanted her not to mess with her child, otherwise she would mess with Sais and her baby. Sadia also told Sais that she had connections and that she had seen Sais traveling on the freeway. Sais stated that at this point she tried to call 911 for help, but Sadia took the receiver out of her hand and stepped on the telephone that was on the floor, attempting to hang up.

At this point Sadia told Sais to go into the bedroom where Sais' baby was in. Sais stated that she then rushed to the bedroom and closed the door behind her in an attempt to keep Sadia away from her baby. Sais stated she then picked up her baby and then heard the screen door slam.

At this time she figured that Sadia left the residence and she went to investigate. Sais stated that she then noticed Sadia outside putting things in her vehicle. Sais then locked the door and called 911 for help. Sais stated that while she was calling the police, she heard Sadia knocking on the door, but at this time she did not open the door. Sais stated that Sadia subsequently left the area.

Sais added that the following day she discovered that her leather wallet, containing a checkbook, credit cards, a telephone directory, her California driver's license, her RN license, and miscellaneous papers were missing from the living room floor. Sais stated she is not sure if Sadia took the wallet or not.

Sais noted that as a result of Sadia pulling her hair, she suffered
